Limits of Insurance

- Property As Per Declared on Application
- Liability \$5,000,000
- D&O \$2,000,000
- AD&D \$ 200,000 (Higher Limits Available)

- General Liability
 - Property Damage at Community Outreach
 Event Demonstration
 - Slip and Fall on Premises Broken Leg
 - Defence of a Third Party Allegation
 - Fundraising Event Third Party Bodily Injury
 - Third Party Bit by SAR Dog

- Medical Malpractice
 - Negligence Allegation of Bodily Injury to Search Victim
- Non-Owned Auto
 - Volunteer Accident Causing Bodily Injury to Third Party While Performing Duty to Organization and Inadequately Insured

- Directors and Officers
 - Bodily Injury to Third Party and Plaintiff Suing for Financial Damages Alleging Inadequate Safety Protocol and Training Procedures for the Volunteers
 - Embezzling or Mismanagement of Funds
 - Board Hired Contractor and Paid for Work,
 Contractor Claims Bankruptcy and Proved
 Board Member has Relationship –
 Mismanagement of Funds

- Property
 - Water Damage to Contents
 - Fire at Storage Location
 - Fire in Building
 - Loss of Laptop Computer
 - Burglary of Equipment
- Watercraft hit rock Resulting in Damage

- Crime
 - Theft of Petty Cash by Volunteer
 - Bank Deposits Stolen on Way to Bank

AD&D

- Death and Dismemberment to Members
- Volunteer Injured During Remote Search and Family Members Visiting Hospital
- Torn Ligament by Volunteer During Search
- Directors Injured Traveling to Scheduled Meetings
- Volunteer Injured During SAR Event
